BUY TICKETS ONLINE

WCT has converted to Vendini Ticket Agency for ticket sales. In addition to purchasing tickets through the box office, this system allows patrons to purchase tickets online at their convenience. Also, for the first time, patrons can use a credit card to purchase tickets, both online and through the box office. With Vendini:

- Buy securely online up to 1 hour before the start of the show
- · Online ticket purchases are assessed a ticket transaction fee and a credit card transaction fee
- Box office purchases paid with cash or check are not assessed fees; Box office purchases paid by credit card are assessed only a credit card transaction fee
- "Tip Jar" donations can be made when purchasing tickets, as part of the transaction
- Tickets can be printed from home or can be held at will call under last name at the Box
- A confirmation email will be sent reflecting the ticket order and charges (sans credit card info).

Joyce MacPhee


